#### SECTION VI – Details, Details, Details

Now that you have provided what you probably think is a LOT of detail, we still need more. Yet it is difficult to formulate questions for every contingency. For example, does SUBJECT live/work in a secured building? Do you know the access codes? Do you have any idea how we can gain entry, if necessary? What about SUBJECT'S office or apartment location within the building itself? Is SUBJECT'S office/apartment the third window from the left on the second floor, or what? Is there any motion dectector lighting? What about child custody issues, if applicable? When do you have the children? How/when does the exchange take place? Do you have a map of the office or residence area? Can you draw one? Which of the windows of the residence is the bedroom window? Are there nosey neighbors who would be suspicious of our presence? Has SUBJECT previously been under surveillance? Why? Did he/she know it? Are there other reasons why he/she might currently be under surveillance [for example, if SUBJECT does not leave home by 10:00PM, discontinue surveillance]? Is SUBJECT violent? Does he/ she carry a weapon? Are there guns in the home? You do not have to answer each of these specific questions. Just let these example questions be a guide as to the types of additional information you can provide that will help us provide an efficient and cost-effective surveillance.
